TERMS & CONDITIONS

1. The promoter is YFG Shopping Centres (ACN 056 974 844) of c/- Retail First Pty Ltd, Stafford City, 400 Stafford Road, Stafford, Queensland, 4053 ("the promoter").
2. How to enter the Spend & Win promotion. Instructions on how to enter this Spend & Win competition form part of the terms and conditions.
3. The promotion commences at 9am on Monday 2nd March and concludes at 6pm on Tuesday 31st March 2020.
4. To go into the draw:
 - a. Entrants must purchase 'goods and services' valued at \$20 or more from any Stafford City Specialty Store, OR \$10 or more in Tang Bakery OR \$100 or more in Woolworths, ALDI, Hoyts and Kmart in one transaction.
